## CONSENT for the Processing of Personal Data

When filling out a form on the internet pages of the website https://rtlalliance.com/, https://investor.rtlalliance.com/, https://venture.rtlalliance.com/, and other internet pages owned by LLC «RTL Alliance,» and by checking the checkbox before pressing the «submit» button, the website user (an individual interested in receiving information from LLC «RTL Alliance») provides voluntary, unequivocal, informed consent to the processing of personal data under the following conditions:

- 1. The Operator (the organization responsible for processing personal data) is Limited Liability Company «RTL Alliance» (address 14 Skryganova Street, Office 65, Minsk, Belarus).
  - 2. The list of personal data for which consent is granted for processing includes:

Name, email address, mobile phone number (if provided by the user), and any other personal data specified by the user in the request, as well as audio recordings of phone conversations.

## 3. Purpose of Processing:

The processing of incoming requests with the aim of providing the data subject with personal information via email (sending informational emails), mobile communication, information about tokens related to transportation and logistics services, and other requested information by the user.

- 4. The consent is granted for a period of 3 years from the date of providing consent.
- 5. List of actions with personal data, a general description of processing methods:

The company may collect, systematize, store, modify, use, block, and delete personal data. Processing is carried out using automated means, without using such means, and in a mixed manner.

- 6. Rights of Data Subjects and Mechanisms for Exercising Them:
- At any time, the data subject can withdraw their consent for the processing of personal data without providing reasons.
- The data subject has the right to obtain information regarding the processing of their personal data.
- If the data is incomplete, outdated, or inaccurate, the data subject can request corrections to their data.
- Once a calendar year, the data subject has the right to receive information about the disclosure of their data to third parties free of charge.
  - The data subject can demand the free termination of data processing and/or their deletion.
- The data subject has the right to appeal the actions/inactions and decisions of the Operator concerning the processing of their personal data to the authorized body for the protection of data subjects' rights, in accordance with the legislation.

To exercise their rights as a data subject, an individual should submit a request to the Operator, which should include the following:

- Full name, including surname, given name, and patronymic (if applicable) of the person whose data is being processed, along with their residential address (place of residence).
  - Date of birth.
  - A statement outlining the nature of the request.
- Identification number, if data processing is carried out on grounds other than the consent provided in this agreement.
  - Personal signature or electronic digital signature of the individual whose data is being processed.

The consequence of providing consent is the granting of the Operator's right to process personal data in accordance with the purposes stated above. The processing of personal data by the Operator is conducted in accordance with the privacy policy, which is available at the following address: https://rtlalliance.com/pdf/RTL\_Data\_Policy\_ENG.pdf.

Refusal to provide consent will make it impossible for the Operator to provide information in response to the user's request on the internet page (an individual interested in receiving information from the Operator).

By checking the checkbox and clicking the «submit» button, the website user confirms that they have reviewed their rights, the mechanisms for their exercise, the consequences of providing or refusing consent for the processing of personal data, as well as the Operator's privacy policy.
